#### ARTICLE I. NAME

The name of this corporation shall be Wille B. Sherman, Jr., DDS, P.A.

#### ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the incorporator. This corporation's duration shall be perpetual.

#### ARTICLE III. PROFESSIONAL SERVICE CORPORATION

### Section A. License

This corporation is specifically formed for rendering the same professional service to the public that the duly licensed Dentist under the laws of this state, is authorized to render.

#### Section B. Powers

The powers of the corporation are to:

## Section C. Conflict Of Interest

Provided due notice is given to this corporation:

- 1. No contract or other transaction between this corporation and any other corporation shall be affected by the fact that any director or officer of this corporation is interested in, or is a director or officer of, such other corporation.
- 2. Any director of this corporation, individually or jointly, may be a party to, or may be interested in, any contract or transaction of this corporation or in which this corporation is interested.
- 3. No contract, or other transaction of this corporation with any person, firm, or corporation, shall be affected by the fact that any director or officer of this corporation is in any way connected with such person, firm or corporation.

#### ARTICLE IV. PURPOSE

This corporation is being organized for the purpose of engaging in the transaction of any and all business activities permitted under the laws of Florida and the United States Of America.

#### ARTICLE V. CAPITAL STOCK

This corporation shall have the authority to issue Common par value shares of common capital stock. The number of shares the corporation shall have is 1000 shares of common capital stock with a par value of \$1.00 per share.

#### ARTICLE VI. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash by this corporation of any shares of new capital stock of the same kind, class, or series, as that which the shareholder already holds, shall have the preemptive right to purchase a pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which such shares are offered to others.

#### ARTICLE VII. TRANSFER RESTRICTIONS

No shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any shares of the capital stock of this corporation, without first offering such shares for sale to this corporation at the net asset value thereof.
