ARTICLES OF INCORPORATION

OF

A.J. SUPER STEAMERS CARPET CLEANING COMPANY

The undersigned, acting as incorporator of **A.J. SUPER STEAMERS CARPET CLEANING COMPANY** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is **A.J. SUPER STEAMERS CARPET CLEANING COMPANY**.

ARTICLE II. ADDRESS

The mailing address of the corporation is 8912 S.W. 142nd Avenue, Suite 421, Miami, Florida 33186.

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence upon the filing of these articles of incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 8912 S.W. 142nd Avenue, Suite 421, Miami, Florida 33186 and the name of the corporation's initial registered agent at that address is Maria A. Rosado.

ARTICLE VII. INCORPORATOR

The name and street address of the incorporator are Maria A. Rosado, 8912 S.W. 142nd Avenue, Suite 421, Miami, Florida 33186.

The incorporator of the corporation assigns to this corporation her rights under Section 607.0201, Florida Statutes, to constitute a corporation, and she assigns to those persons designated by the board of directors any rights she may have as incorporator to acquire any of the capital stock of this corporation, this assignment becoming effective on the date corporate existence begins.


ARTICLE VIII. BYLAWS
