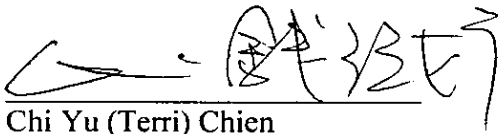
We moved our address to above shows & informed the post office; however, we did not receive the UBR from your office. Actually, I never receive UBR from your office since we established the company,
