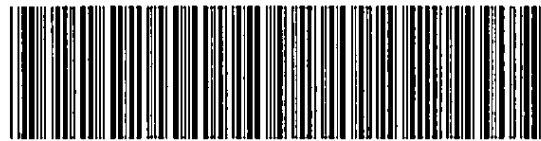

Article III of the Articles of Incorporation of this corporation are amended, and, as amended, Article III shall read as follows:

The number of shares that this corporation is authorized to have outstanding at any one time is:

One Hundred Thousand Shares of Common Stock, all of one class, but divided into Two Thousand shares of Common Voting Stock and Ninety-Eight Thousand shares of Common Non-Voting Stock.

The Recapitalization shall be accomplished by collecting all 7,500 issued and outstanding shares of old Common Stock and replacing them with 2,000 shares of new Voting Common Stock and 98,000 shares of new Non-Voting Common Stock.

Since there are presently only two Stockholders each holding 3750 shares of old Common Stock, the number of new shares to be issued to each shall be 1,000 shares of Voting Common and 49,000 shares of Non-Voting Common.


