The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

**ARTICLE ONE - NAME**

The name of the corporation is **Southern Offshore, Inc.**

**ARTICLE TWO - PRINCIPAL OFFICE**

**ARTICLE THREE - CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE FOUR - PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:
