ARTICLES OF INCORPORATION

The Undersigned hereby execute(s) and acknowledge(s) these Articles of Incorporation in order to organize and incorporate a business for profit, under the corporate name as stated in ARTICLE IX.

ARTICLE I - PURPOSE(S)

The Corporation may engage in the business or profession stated in $A \ R \ I \ I \ C \ L \ E \ I \ X$ and any other transaction or business permitted under the laws of the United States and of this State.

ARTICLE II - DURATION

The duration of this Corporation shall be perpetual. Corporate existence shall commence at the time stated in A R T I C L E I X, provided that all of the requirements of law are met.

ARTICLE III - REGISTERED OFFICE - AGENT

The street address of the Registered Office and the name of the Registered Agent at said address shall be as stated in A R I I C I E I X.

ARTICLE IV - NUMBER of DIRECTORS

The number of Directors constituting the initial Board of Directors, if any, are stated in <u>ARTICLE</u>

<u>IX</u>. The number of the Board of Directors, if any, shall be determined, from time to time, by the by-laws.

ARTICLE V-INCORPORATORS AND DIRECTORS

The name and address of each Incorporator and the name(s) and address(es) of the Members of the initial Board of Directors of this Corporation are stated in A R I I C L E V I I I.

ARTICLE VI-INCORPORATION by REFERENCE

Each of the Powers stated herein shall not be in limitation, but shall be in enumeration, of the Powers of the Corporation. In addition, the Corporation shall have all other Powers as are now, or hereafter, conferred upon it by law.

ARTICLE VII - POWERS of CORPORATION

11. To elect or appoint officers and agents of the Corporation, and define their duties and fix their compensation.

12. To make and after by laws, not inconsistent with its Articles of Incorporation or with the laws of this State, for the administration and regulation of the affairs of the Corporation.
