ARTICLES OF INCORPORATION OF  
**Savoy Trucking, Inc.**

ARTICLE I - Name

The name of the corporation is: Savoy Trucking, Inc.

ARTICLE II - Existence

This corporation shall commence existence upon receipt and filing of these articles.

ARTICLE III - Purpose

The general purpose for which this corporation is organized shall be the transacting of any or all lawful business for which corporations may be incorporated under the provisions of Chapter 607, Florida Statues.

ARTICLE IV - Capital Stock

## ARTICLE VIII - Incorporator



This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.




