**ARTICLES OF INCORPORATION
OF
MICHAEL GRADY AND NEW GULF COAST SINGERS, INC.**

The undersigned incorporators of these articles of incorporation, each a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

Article I - Name of Corporation.

The name of this corporation shall be MICHAEL GRADY AND NEW GULF COAST SINGERS, INC..

Article II - General Nature of Business.

The corporation may engage in the running and operating of any activity or business permitted under the laws of the State of Florida and of the United States of America.

Article III -Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one hundred (100) shares of common stock, having a par value of \$1.00 per share. The common stock holders have unlimited voting rights and are entitled to receive the net assets of the corporation upon dissolution. The initial stockholders are Michael Louis Grady 50 shares and Mechelle Yvette Grady 50 shares.

Authorized capital stock may be paid for in cash, services, or property.

ARTICLE IV - Term of Existence

This corporation shall have perpetual existence.

Article V - Place of Business

The principal place of business is 6020 Cherry St., Panama City, Florida 32404

Article VI - Registered Office and Registered Agent
