

ARTICLES OF INCORPORATION

OF

ROBBY'S CUSTOM AUTOMOTIVE, INC.

The undersigned hereby subscribes himself for the purpose of becoming a corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I NAME

The name of this Corporation will be: ROBBY'S CUSTOM AUTOMOTIVE, INC.

ARTICLE II GENERAL NATURE OF BUSINESS

The Corporation may engage in any activity or business authorized and permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III CAPITAL STOCK

The total number of shares of capital stock which may be issued by this Corporation is One Hundred (100) shares of a par value of fifty cents (\$0.50) per share, all of which will be common stock and will be fully paid and non-assessable.
