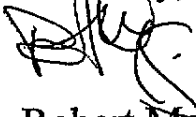

The undersigned hereby subscribes himself for the purpose of becoming a corporation under the Laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I
NAME

The Corporation may engage in any activity or business authorized and permitted under the laws of the United States of America and of the State of Florida.

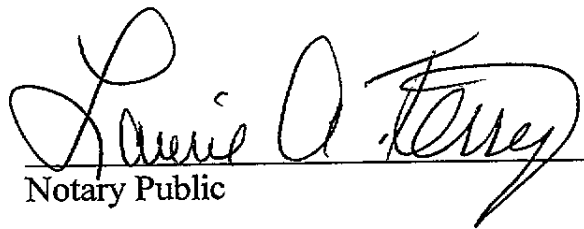
