#### ARTICLES OF INCORPORATION

OF

The undersigned Incorporator hereby files these Articles of Incorporation in order to form a Corporation under the laws of the State of Florida, effective upon filing with the Florida Secretary of State.

# ARTICLE I. Name and Principal Office

The name of this Corporation shall be **SCRAPBOOK MARKET**, **INC.** The principal place of business and mailing address of this Corporation is 3739 Bobbin Brook West, Tallahassee, Florida 32312.

# ARTICLE II. Nature of Business

The Corporation is organized for the purpose of engaging in any or all activity or business permitted under the laws of the United States of America and the State of Florida.

#### ARTICLE III. Stock

The authorized capital stock of this Corporation shall consist of 1000 shares of common stock with a par value of \$1.00 per share.
