ARTICLES OF ORGANIZATION

The undersigned incorporator, for the purpose of forming a corporation (hereinafter referred to as the "Corporation") under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I: The name of the Corporation shall be PRANICH & ASSOCIATES MIAMI, INC.

Article II: The principal place of business and mailing address of the Corporation shall be 400 Clematis Street, Suite 200, West Palm Beach, Florida 33401.

Article III: The number of shares of stock that the Corporation is authorized to have outstanding at any one time is 1,000, all of which are without par value and classified as Common shares.

Article IV: The name and address of the initial registered agent is Noranit Tui Pranich, 400 Clematis Street, Suite 200, West Palm Beach, Florida 33401.

The written acceptance of the initial registered agent as required by the provisions of Section 607.0501(3) of the Florida Business Corporation Act, is set forth following the signature of the incorporator and is made a part hereof.

Article VI: The purposes for which the Corporation is organized, in addition to engaging in any or all lawful business for which corporations may be incorporated under the provisions of the Florida Statutes, are as follows:

- a. To carry on the business of a showroom for interior furnishings and decorative products; and
- b. To manufacture, buy, sell, import, export, trade and deal in furniture and furnishings, decorative accessories, objects d'art, draperies, fabrics, upholstery, fixtures, wallcoverings of all kinds, rugs, carpets, and floor coverings of all kinds, paintings, mantels, mirrors, china, silver, glassware and articles of every nature and description which can be used in connection with the business of a showroom for interior furnishings and decorative products.

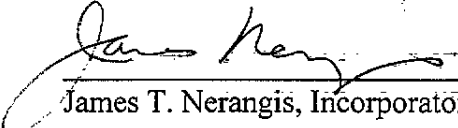
Article VII: All officers of the Corporation are to be elected by the shareholders of the Corporation; each such officer shall hold office for such term as may be determined by the shareholders.

Article VIII: The shareholders shall have complete power and control over the management and business of the Corporation.

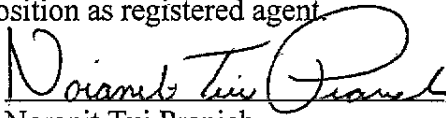
Article IX: The period of duration of the Corporation is perpetual.

Article X: The Corporation shall, to the fullest extent legally permissible under the provisions of the Florida Business Corporation Act, as the same may be amended and supplemented, shall indemnify and hold harmless any and all persons whom it shall have power to indemnify under said provisions from and against any and all liabilities (including expenses) imposed upon or reasonably incurred by him in connection with any action, suit or other proceeding in which he may be involved or with which he may be threatened, or other matters referred to in or covered by said provisions, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director or officer of the Corporation. Such indemnification provided shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any law, Agreement or Resolution adopted by the shareholders entitled to vote thereon after notice.
