#### ARTICLES OF INCORPORATION



## Rx VALUE USA, INC.



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

#### ARTICLE I. NAME

The name of the corporation is: Rx Value USA, Inc.

## ARTICLE II. PRINCIPAL OFFICE
