ARTICLES OF INCORPORATION

of

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE I
CORPORATE NAME AND PRINCIPAL ADDRESS

The name of this Corporation is Classic Electrical Contractors, Inc. The principal address of the corporation is 15551 93rd Street North, West Palm Beach, FL 33412.

ARTICLE II
PURPOSE

The general purposes for which the corporation is organized are:

1. To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
2. To do such other things as are incidental to the above or necessary or desirable in order to accomplish the above.

ARTICLE III
DURATION

The duration of the corporation is perpetual.

ARTICLE IV
CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is 1000. Such shares shall be of a single class, and shall have a par value of \$1.00 per share.

ARTICLE V
PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI
INITIAL BOARD OF DIRECTORS
AND OFFICERS

This corporation shall have two (2) directors initially. The number of directors may be increased or decreased from time to time by the By-Laws but never shall be less than one. The name and address of the initial directors, vice president secretary and treasurer of this corporation is:

ARTICLE VIII
INDEMNIFICATION

This corporation shall indemnify any officer of director or any former officer or director to the fullest extent permitted by law.

ARTICLE IX
BY- LAWS

The initial directors shall submit bylaws to the shareholders at a meeting to be held for that purpose not more than thirty (30) days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by affirmative vote, the internal affairs of the corporation are to be regulated and managed in accordance with the by-laws. The power to alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

ARTICLE X
AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, and any right conferred upon the shareholders is subject to this reservation.

ARTICLE XI
DISSOLUTION


The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds of the outstanding

shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payments of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.
