ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF GENERAL DIVERSIFIED CORP.

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, General Diversified Corp., a Florida corporation, does hereby amend its Articles of Incorporation

- I. The name of the corporation whose Articles of Incorporation are being amended by these Articles of Amendment is General Diversified Corp., a Florida corporation.
- Article I of the Articles of Incorporation of General Diversified Corp., a Florida corporation, is hereby deleted in its entirety, and the following Article I is hereby inserted in its place:
