

**ARTICLE I - NAME - LOCATION**

The name of this corporation is CENTER FOR PROGRESSIVE PAIN MANAGEMENT, INC, located at 1154 N. W. 108<sup>th</sup> Terrace, Plantation, Florida 33322.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing on the date of execution and acknowledgment of these articles.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**


**ARTICLE IX - AMENDMENT**

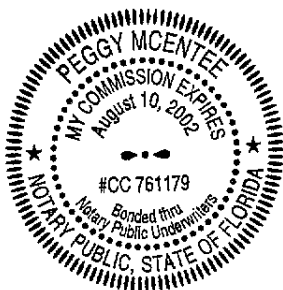
