CAPITAL STOCK



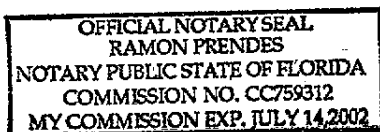


