As per instructions this morning, enclosed please find a check in the amount of \$150 as the reporting/filing fee for the year 2001 and for reactivating of the Company.

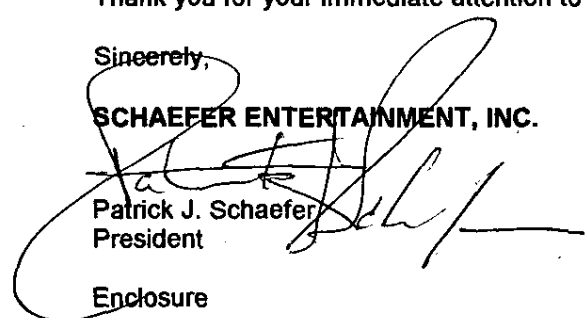
