The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida..

ARTICLE I. NAME

The name of the corporation shall be:

HOME BUILDING & REPAIR, INC.

The address of the principal office of this corporation shall be 4117 Southwest 20th Avenue, Apt. 206, Gainesville, Florida 32607, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
