The undersigned incorporator to these Articles of Incorporation hereby forms a softporation under the laws of the State of Florida as follows:

Article I Name and Address

The name of this Corporation is **MANAGELAWN CORPORATION**. The mailing address of the Corporation is Post Office Box 20112, Tampa, Florida 33630-9998. The street address and mailing address of the Corporation is 405 North Reo Street, Suite 240, Tampa, Florida 33609.

Article II Term of Existence

This Corporation shall have perpetual existence, commencing upon the filing of these Articles of Incorporation.

Article III Purpose

This Corporation is organized for the purpose of transacting any and all lawful business.

Article IV <u>Powers</u>

This Corporation shall have the power:

- (a) To have perpetual succession by its corporate name.
- (b) To sue and be sued, complain, and defend in its corporate name in all actions or proceedings.
