**ARTICLES OF INCORPORATION

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation shall be: FORDDIRECT.COM, INC.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 1333 N. Federal Highway, Fort Lauderdale, Florida, 33304.

**ARTICLE III - CAPITALIZATION**

The aggregate number of shares that the corporation shall have authority to issue is 500 shares, all of which shall be common shares with individual par value of \$1.00.

The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than ten persons. Stock will be issued and transferred only to (1) natural persons, (2) estates, or (3) a trust as described in title 26 United States Code Section 1371 defining a qualified "small business corporation".

**ARTICLE IV - INITIAL REGISTERED AGENT AND STREET ADDRESS**

The name and Florida street address of the initial registered agent are: LEO HILLOCK at 1333 N. Federal Highway, Fort Lauderdale, Florida 33304.

**ARTICLE V - INCORPORATOR**

The name and address of the incorporator to these Articles of Incorporation are: LEO HILLOCK at 1333 N. Federal Highway, Fort Lauderdale, Florida 33304.

**ARTICLE VI - CORPORATE DURATION**

The corporation shall commence to be in existence upon the filing of these Articles of Incorporation by the Department of the State of Florida and the term of existence shall be perpetual.

**ARTICLE VII - PURPOSES**

The purpose of the corporation is to engage in e-commerce and related aspects of Internet services.

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act, or engage in any other trade or business which can, in the opinion of the Board of Directors, be advantageously carried on in connection with or auxiliary to the foregoing business.

To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
