**ARTICLE I-NAME**

The name of this corporation is **A STATION FOR DICTATION, INC.**

**ARTICLE-II-DURATION**

This corporation shall have perpetual existence commencing on August 1, 1999 at 12:00 A.M. after the filing of these Articles with the Department of State.

**ARTICLE III-PURPOSE**



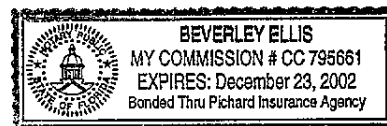
