#### ARTICLES OF INCORPORATION

### ARTICLE I NAME

The name of this Corporation is: UNITED PHYSICIAN'S SERVICES, INC.

# ARTICLE II DURATION

This Corporation shall exist perpetually.

## ARTICLE III PURPOSE

This Corporation is organized for the purpose of operating as a Group Purchasing Service for Medical & Dental Offices. This includes Nursing and Assisted Living Facilities, as well as Out-Patient Surgical Centers and Walk-In Clinics.

# ARTICLE IV CAPITAL STOCK

This Corporation is authorized to issue 500 shares of Capital Stock with a par value of \$ 1.00 per share. These shares shall be designated as "Common Shares". There will be only this one (1) type of stock.
