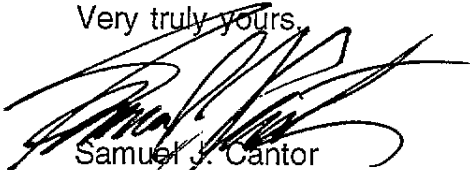

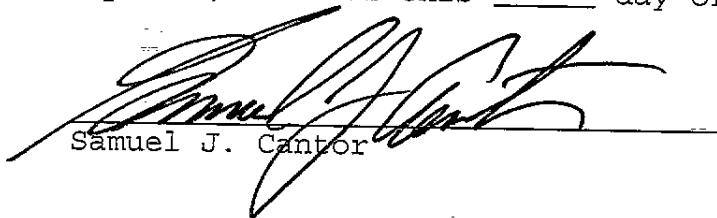
ARTICLE VIII

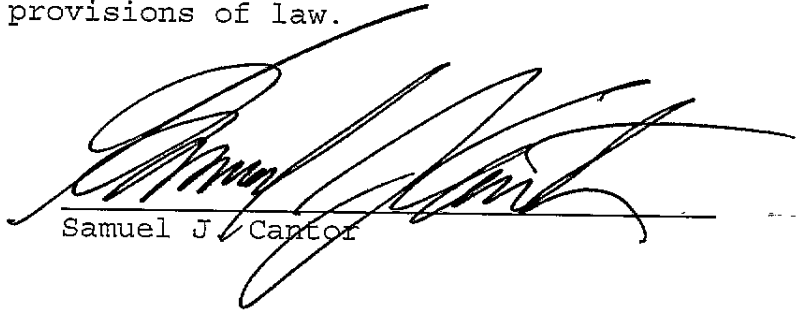
