## ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

## <u>ARTICLE I - NAME</u>

The name of the corporation is SHINDELAR APPRAISAL SERVICES, INC.
