ARTICLES OF INCORPORATION OF STUDIO BD, INC.

ARTICLE I NAME

The name of the corporation is STUDIO BD, INC.



ARTICLE II DURATION

The corporate existence shall commence on the date of filing, and the duration of the corporation shall be perpetual.
