ARTICLES OF INCORPORATION OF STATE TERN POINT ENTERPRISES. INC. SECRETARY OF STATE ALLAHASSEF, FLORIDA

ARTICLE I. NAME

The name of this corporation shall be: Tern Point Enterprises, Inc.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filling of these Articles of Incorporation by the Secretary of State. This corporation's duration shall be perpetual.

ARTICLE VI. TRANSFER RESTRICTIONS
