ARTICLES OF INCORPORATION OF CLEAN CUT LAWN CARE, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

The name of this corporation shall be Clean Cut Lawn Care, Inc.

Article II <u>Principal Office and Mailing Address</u>

Article III Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 1,000,000 shares of common stock having a par value of \$0.01 per share. The shareholders of this corporation shall have preemptive rights.

Article IV Initial Registered Agent and Address
