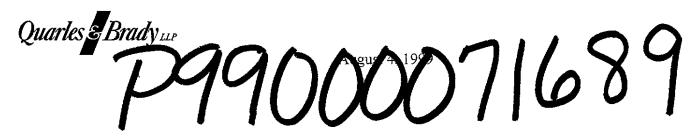

ARTICLES OF INCORPORATION

OF

BRANDS@WORK, INC.



I, the undersigned natural person, acting as incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I Name

The name of the corporation is Brands@Work, Inc.

ARTICLE II Principal Office and Mailing Address

The address of the principal office of the corporation is 100 Almeria Avenue, Suite 230, Coral Gables, Florida 33134, and the mailing address of the corporation is the same.

ARTICLE III Purposes

The purposes for which the corporation is organized are to engage in any lawful activity within the purposes for which a corporation may be organized under the Florida Business Corporation Act.

ARTICLE IV Capital Stock

The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000) shares, consisting of one class only, designated as "Common Stock," of the par value of one cent (\$.01) per share.

ARTICLE V <u>Directors</u>
