

ARTICLES OF INCORPORATION

OF

DANCE CREATIONS BALLROOM, INC.

The undersigned hereby subscribes to these Articles of Incorporation for any legal purpose permitted under the laws of the State of Florida and of the United States of America.

ARTICLE I

The name of the Corporation is: DANCE CREATIONS BALLROOM, INC.

ARTICLE II

NATURE OF BUSINESS

Any and all legal purpose permitted under the laws of the State of Florida and of the United States of America.

ARTICLE III

CAPITAL STOCK

The maximum number of shares of stock with a nominal or par value that this corporation is authorized to have outstanding at anytime, together with the distinguishing characters of each, into which same are divided, and the par value of shares of stock, other than shares which have no par value or nominal value as follows: ONE THOUSAND (1,000) with a par value of One Cent (\$0.01) per share and each share having equal rights, privileges and voting power.

TERM OF EXISTENCE

This corporation shall have perpetual existence.


