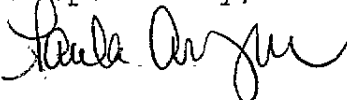

ARTICLE ONE

The name of the corporation is RAPA, INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE
