**ARTICLE I - NAME**

The name of this corporation is uOWN2.COM, INC.

**ARTICLE II - DURATION**

This corporation shall have a perpetual existence commencing on August 3, 1999.

### ARTICLE XI - AMENDMENT

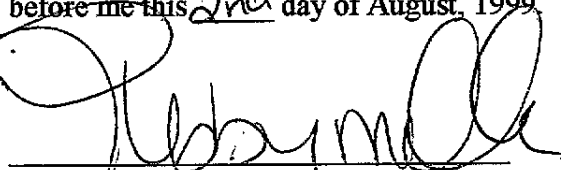
