ARTICLES OF INCORPORATION TREASURE COAST UNITED SOCCER CLUB INC.

SOANG PH. S. P. S. The undersigned, for the purposes of forming a corporation under the Florida Business Corp Act, hereby adopt the following articles of incorporation:

ARTICLE ONE

1.01 The name of this corporation is TREASURE COAST UNITED SOCCER CLUB INC.
