# **ARTICLES OF INCORPORATION**

THE UNDERSIGNED INCORPORATOR to these Articles of Incorporation is a natural person competent to contract and form a corporation under the laws of the State of Florida and does certify that **Double R Hauling, Inc.** has become a corporation under and pursuant to the following Articles of Incorporation.

#### ARTICLE I
