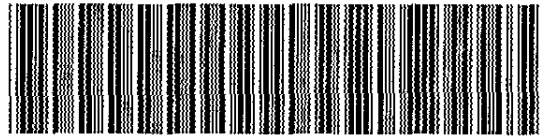

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the corporation is Alpine Venture Capital Corp.

SECOND: The Corporation hereby amends its Articles of Incorporation by changing Article "I" thereof, so that, as amended, said Article shall be and read as follows:

"ARTICLE I: Name. The name of the corporation is
