I, the undersigned subscriber to these Articles of Incorporation, do hereby form  
a corporation for profit under Chapter 607 of the laws of the State of Florida, as follows:

**ARTICLE I: NAME**

**ARTICLE II: NATURE OF BUSINESS**


#### ARTICLE VII: INCORPORATORS
