

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE VI. POWERS


The corporation may exercise any power without limitation whatsoever, which a corporation may legally exercise under the Florida Business Corporation Act.

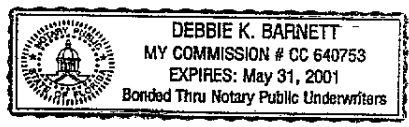





