ARTICLES OF INCORPORATION

OF

ACC CONSTRUCTION, INC.



ARTICLE ONE

The name of this corporation is ACC CONSTRUCTION, INC. and the mailing address of the corporation shall be 3920 30th Avenue SE, Naples, Florida 34117.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

The duration of the corporation is perpetual.
