

I am writing to address several issues regarding the corporation Antonin International Communication Group, Inc. The address for mailing correspondences since February 23, 2000, has been Post Office Box 33494, Palm Beach Gardens, Florida 33420-3494. I received a second notice to file the 2000 Uniform Business Report in September, seven months after my official change of address with the U.S. Postal Services. I never received a first notice.

Although the business, Antonin Intl. Comm. Group, Inc., has been incorporated since August of 1999, it has never started transacting businesses because of several factors. The primary purpose was to offer translation services in Palm Beach County. However, shortly before the business was incorporated, the State of Florida imposed new mandate to require State Certification for all translators. I had to wait until March 2000 for the next examination. The entire business endeavor was put to hold, and unfortunately, never could regain the momentum because of my many professional engagements (i.e., teaching, conference coordination, etc.)

I waited for the renewal notice for corporation status to dissolve the corporation, but as stated before, I never received it. The corporation received a Federal Tax (EIN 65-0936105), but never transacted any business. I enclose the required form and the fee for dissolution of corporation.
