Also enclosed are two checks for \$450.00 each for years 2000, 2001, and 2002 for each of the corporations.

Request abatement of the \$600 reinstatement fee for each of the corporations.

Since the corporations were started the corporate address was 2151 Alternate A1A, Suite 650, Jupiter, FL 33477. However, in July of 2000, the offices of both corporations were moved to 851 W. Indian Road, Jupiter, FL 33458. Neither I, my staff, or the staff of the two corporations recall receiving the annual reports for year 2000, 2001, or 2002. We do not recall receiving any other notices either. Although both corporations moved, a proper forwarding notice was in place. Nevertheless, the annual reports or other notices have not been received. As accountants, we understand how important it is to maintain the corporation status by filing the annual report.

This year, before doing a corporate tax return, it is part of my process to see that each corporation paid its \$150 annual fee (or \$61.25 for a not for profit). If they did not, they are informed of the required corrective action. This year I checked all my corporation clients with your web site. It was my surprise that the above two corporations were listed as inactive.

In summary, request abatement of the \$600 reinstatement fee for each corporation.
