WHEREAS, it is the intention of the Incorporator of the corporation that the Articles of Incorporation of the corporation be amended in accordance with the proposed amendment hereinafter set forth;

WHEREAS, the proposed amendment to the Articles of Incorporation of the corporation hereinafter set forth was approved by the Incorporator of the corporation pursuant to the provisions of Florida law and shareholder action was not required; and

WHEREAS, the Incorporator has adopted a Resolution as of September 24, 1999 calling for the amendment to the Articles set forth herein.

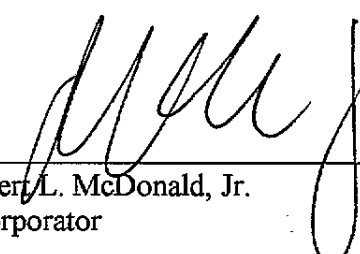
NOW, THEREFORE, THE Articles of Incorporation of Sorcam Software Technology, Inc. are hereby amended as follows:

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 300,000 shares of common stock at \$.01 par value.

The corporation elects to have preemptive rights as set forth in Florida Statute 607.0630.
