ARTICLES OF INCORPORATION OF KIRKPLAN KITCHENS OF SARASOTA, INC

ARTICLE I

<u>Name</u>. The name of this corporation is KIRKPLAN KITCHENS OF SARASOTA, INC.

ARTICLE II

Duration. The corporation shall be perpetual.

ARTICLE III
