The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I - Name of Corporation**

The name of this corporation shall be: Global Investors Group, Inc.

**ARTICLE II - Duration**

The term of existence of the corporation is perpetual, commencing upon the filing of these Articles of Incorporation with the Department of State, State of Florida.

**ARTICLE III - Purpose and Powers**

The corporation may transact any and all lawful business for which corporations may be incorporated under Florida's General Corporation Act, as in effect from time to time. The corporation shall have all the powers set forth in said Act, as in effect from time to time.

**ARTICLE VII - Directors**

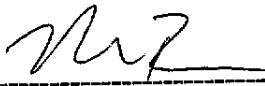
This corporation shall not have less than one director initially. The number of directors may be increased or diminished from time to time through Bylaws adopted by shareholders.

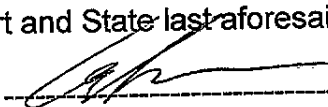

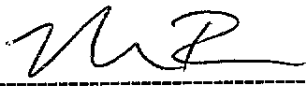
