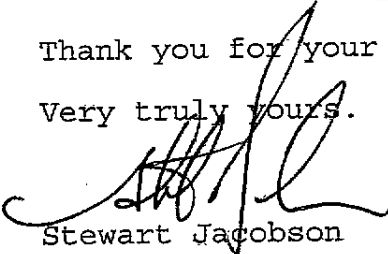

NAME

The name of this corporation is: Tropical Drywall Service, Corp.

ARTICLE II

That this corporation shall engage in any activity permitted under the laws of the State of Florida and the United States of America.

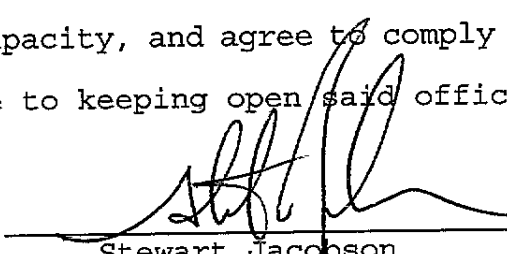

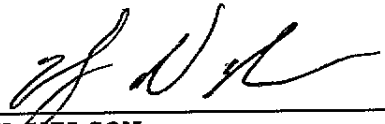
