**ARTICLE I. NAME**

**The name of this professional corporation shall be: MICHAELANGELO  
ROSARIO IMMIGRATION ATTORNEY PROFESSIONAL CORP.**

**ARTICLE II. COMMENCEMENT & DURATION**

**The commencement of this corporation's existence shall be at the time of the  
filing of these Articles Of Incorporation by the Department of Corporations.  
This corporation's duration shall be perpetual.**

**ARTICLE III. PURPOSE**

**This corporation is being organized for the purpose of engaging in the  
transaction of any and all business activities permitted under the laws of  
Florida and the United States of America.**

**ARTICLE IV. CAPITAL STOCK**

**This corporation shall have the authority to issue 1000 shares of Capital Stock  
at \$1.00 (One Dollar) par value.**

**ARTICLE V. PREEMPTIVE RIGHTS**

**Every shareholder, upon the sale for cash by this corporation of any shares of  
new capital stock of the same kind, class, or series, as that which the  
shareholder already holds, shall have the preemptive right To purchase a pro  
rata share thereof ( as nearly as may be done without the issuance of  
fractional shares) at the price at which such shares are offered to others.**

## **ARTICLE VI. TRANSFER RESTRICTIONS**

**No shareholder shall have the right to sell, assign, pledge, encumber, transfer, or otherwise dispose of any shares of the capital stock of this corporation, without first offering such shares for sale to this corporation at the net asset value thereof. Such offer shall be in writing, signed by the shareholder, sent by registered or certified mail to this corporation at its registered office address, and open for acceptance by this corporation for a period of fifteen days from the date of mailing. If this corporation fails or refuses, within such period, to make satisfactory arrangements for the purchase of such shares, the shareholder shall have the right to disposed of such shares without any further restrictions.**

**On the death of any shareholder, this corporation shall have the right to purchase any shares of the capital stock of this corporation owned by the shareholder immediately prior to the shareholder's death, on the terms set forth above, and this provision shall be binding upon the personal representzative of the shareholder.**

**Each stock certificate issued by this corporation shall carry the following legend:**

**"These Shares Are Held Subject to Certain Transfer Restrictions Imposed By This Corporation's Articles Of Incorporation, A Copy Of Which is On File At This Corporation's Principal Office."**

## **ARTICLE VII. INITIAL OFFICERS**

**The number of directors on this corporation's Initial Officers shall be 1. The number of officers may be increased or decreased from time to time, as provided in this corporation's bylaws, but shall never be less than one. There will be no board of directors at the present time.**

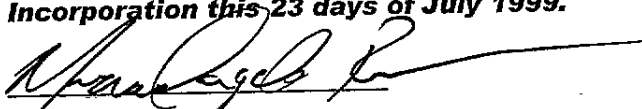

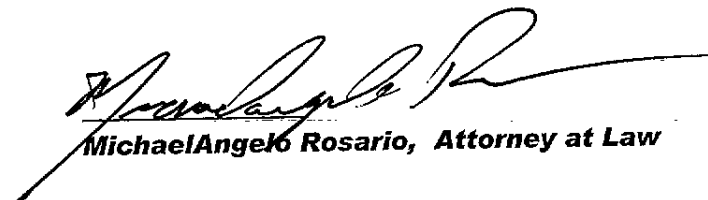
