The name of this corporation shall be Donovan D. Carr, P.A.

ARTICLE II. DURATION





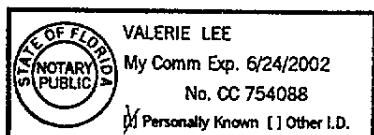
