ARTICLES OF INCORPORATION OF

SPECIALTY ROOFING AND COATINGS COMPANY

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is SPECIALTY ROOFING AND COATINGS COMPANY.

ARTICLE II

The existence of the corporation shall begin on the date these Articles are filed.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is one hundred (100), all of which shall be Common Shares.
