ARTICLE I - NAME

The name of the corporation shall be: RICKLEE TAVERN, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.


ARTICLE IX - INDEMNIFICATION



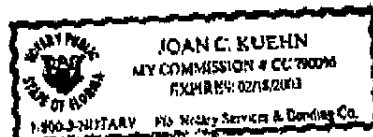


