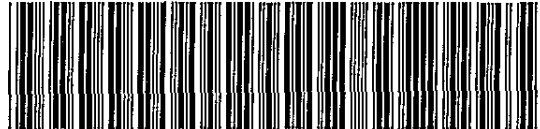

Based on a recent internet search that process was never completed and I am submitted the attached resignation as an officer/director.


