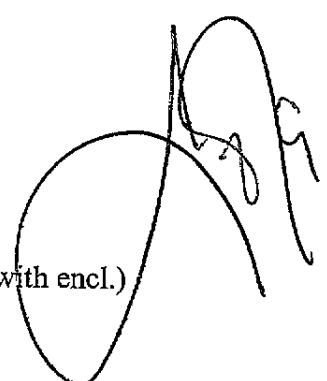

The corporation shall indemnify, to the full extent permitted by law, the Incorporator, and any Officer or Director of the corporation.

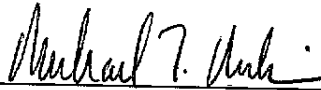
